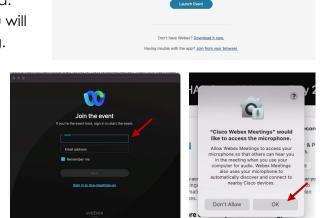
## If joining using the meeting link

### Microphone

# If you cannot hear or be heard

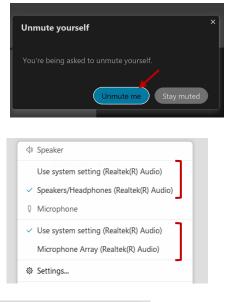
Click on the bottom facing arrow located on the Mute/Unmute button.

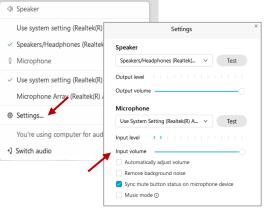
From the pop-up window, select a different:

# Audio Connectivity Issues

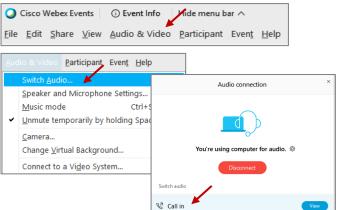
If you are connected by computer or tablet and you have audio issues or no microphone/speakers, you can link your phone through Webex. Your phone will then become your audio source during the meeting.



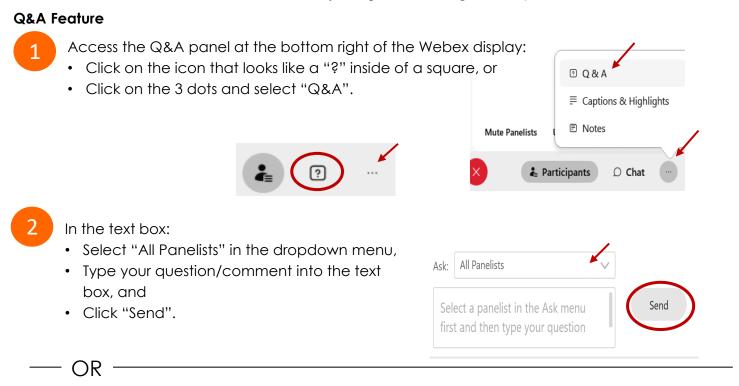
Click on "Audio & Video" from the menu bar.

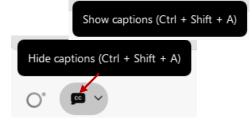

# **Closed Captioning**

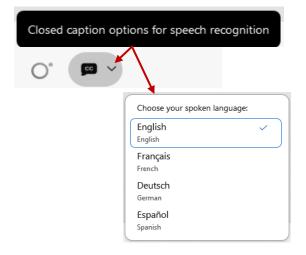
Webex provides real-time closed captioning displayed in a dialog box on your screen. The captioning box can be moved by clicking on the box and dragging it to another location on your screen.
